**Report Definitions:**

***ENERGY STAR Score:*** The ENERGY STAR Score is a measure of how well your property is performing relative to similar properties, when normalized for climate and operational characteristics.

***Property GFA:*** The Gross Floor Area (GFA) is the total property square footage, measured between the outside surface of the exterior walls of the building(s). This includes all areas inside the building(s) including supporting areas.

***Property Type:*** The property type indicates the single, primary use of your property.

***Site EUI:*** The annual amount of all the energy your property consumes on-site, as reported on your utility bills, divided by the property square foot.

***Source Energy Use:*** Source Energy Use is the total amount of raw fuel that is required to operate your property. In addition to what the property consumes on-site, source energy includes losses that take place during generation, transmission, and distribution of the energy, thereby enabling a complete assessment of energy consumption resulting from building operations.

***Total Greenhouse Gas Emissions:*** Greenhouse Gas (GHG) Emissions are the carbon dioxide (CO<sub>2</sub>), methane (CH<sub>4</sub>), and nitrous oxide (N<sub>2</sub>O) gases released into the atmosphere as a result of energy consumption at the property. Total Emissions is the sum of emissions associated with onsite fuel combustion and emissions associated with purchases of electricity, district steam, district hot water, or district chilled water which occur at your utility's plant and are a result of your property's energy consumption.


***Weather Normalized Source EUI:*** The Source EUI use your property would have consumed during 30-year average weather conditions. For example, if 2012 was a very hot year, then your *Weather Normalized Source Energy* may be lower than your *Source Energy Use*, because you would have used less energy if it had not been so hot.
